RULES FOR ANNUAL CLUB CHAMPIONSHIP

1. If any participant gives a walkover voluntarily then the opponent must inform the Tournament Committee in writing before the last date of the round otherwise the match will be treated as abandoned. The participant giving a walkover should also inform the Tournament Committee. Member Secretary or the Club Office in writing or at least by telephone.
2. The match play will be on the basis of **full handicap** as per the current handicap on the day of the match.
3. Local rules on the day of the time match will apply.
4. All other rules will be as per the international Statutory Golf Rules.
5. In the match play, in case of a tie, the result of each round must be completed within the specified time. It is the duty of each player to co-ordinate with his or her opponent and fix up the date and time of the match within the specified date of each round and should immediately notify the club for necessary coordination.
6. No matches will be accepted beyond the specified date.

7. If after fixing time and date, anyone of the opponent fails to reach the 1st tee within 15 minutes of the fixed time then the participant waiting at the tee will get a walkover which should be informed in writing to the Tournament Committee and handed over to the Member Secretary/Club Office on the same day by the waiting player (penalty as per rule 33.7 is applicable).
8. If any participant fails to contact the opponent the he/she should come to the 1st tee on the last date of the specified round at 1:30 P.M. and wait for 15 minutes. If by then the opponent does not reach the first tee, it will be an automatic walkover, which should also be made known to the Tournament Committee in writing on the same day and handed over to the Chief be confirmed by sudden death.
9. Any dispute to be referred to the Tournament Committee and the decision of the Tournament Committee will be final.
